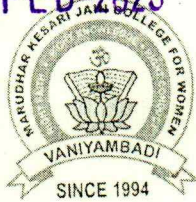


Access to laboratory, library and other supporting facilities for jointly supervised UG, PG and Research will be provided by both institutes.
