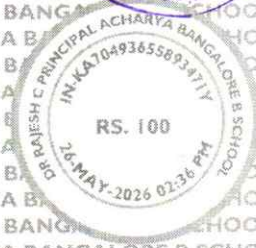

Memorandum of Understanding (MoU)

Between

and

Marudhar Kesari Jain College for Women

Marudhar Kesari Jain College for Women (MKJC), represented by **Dr. M. Inbavalli, Principal**, located at Vaniyambadi – 635751, Tamil Nadu.

PREAMBLE

Whereas, Acharya Bangalore B School and Marudhar Kesari Jain College for Women have many areas of common interest in academics, research, and educational development, and both institutions believe that mutual cooperation would enhance academic excellence and institutional growth.

Now therefore, both institutions have decided to enter into this Memorandum of Understanding (MoU), which defines the framework for cooperation between the two institutions in the areas set out in the following articles.

Article 1: Objectives

Both institutions agree to develop the following collaborative activities in academic areas of mutual interest on the basis of equality and reciprocity.

The two institutions shall seek to promote:

A. Faculty Exchange

- a) Exchange of faculty members for the mutual benefit of both institutions.
- b) Collaboration in teaching, research, and development in areas of mutual interest.
- c) Conducting guest lectures, workshops, and training programs.
- d) Undertaking joint research activities and academic projects.
- e) Attachment of staff for curriculum development and enhancement of teaching and research skills.
- f) Participation in seminars, symposiums, conferences, FDPs, and other academic discussions.

A specific plan will be worked out for each activity, setting forth detailed arrangements for collaboration. Terms and conditions for each visit or exchange, including funding and accommodation, shall be mutually agreed upon by both institutions.

B. Student Exchange

Acharya Bangalore B School and Marudhar Kesari Jain College for Women agree that student exchange activities shall be guided by the Heads of the respective Departments.

- a) Exchange students shall be selected by mutual agreement between the institutions.
- b) Students may participate in seminars, symposiums, workshops, industrial visits, and other academic activities.
- c) Students may attend lectures and training programmes organized by the respective institutions.
- d) The host institution shall evaluate the performance of exchange students and may issue certificates or letters of participation/completion.
- e) Expenses related to student exchange programmes shall be mutually discussed and decided by both institutions from time to time.
- f) Students, faculty members, and staff of both institutions may be permitted to use library and academic facilities available in the respective campuses.

Both institutions further agree that detailed terms and conditions governing each activity identified above shall be separately discussed and mutually approved. These terms shall include the description of the proposed activity, financial arrangements, and responsibilities for implementation.

Article 2: Coordination

Each institution shall appoint one member of its teaching faculty as Programme Coordinator to coordinate the activities under this MoU.

A coordination committee consisting of one Programme Coordinator from Acharya Bangalore B School and one Programme Coordinator from Marudhar Kesari Jain College for Women shall periodically review and identify ways to strengthen cooperation between the two institutions.

Article 3: Validity

This MoU shall remain in force for a period of **THREE (3) YEARS** with effect from the date of signing.

The terms of the MoU may be extended by mutual written agreement signed by both institutions after review.

Article 4: Termination

Either institution may terminate this MoU by giving **three months' prior written notice** to the other institution.
