MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding (MoU) is made and entered into on this 17th day of October, 2025, by and between:

Marudhar Kesari Jain College for Women (Autonomous), located at NH 179A, Marudhar Nagar, Chinnakallupalli, Vaniyambadi, Tamil Nadu-635751, hereinafter referred to as "MKJC",

And

Rourkela Institute of Management Studies, located at Institutional Area, Gopabandhu Nagar, Chhend, Rourkela -769015, Odisha, hereinafter referred to as "RIMS".

Preamble:

Recognizing the mutual benefits to be gained through a cooperative program promoting academic, research, and cultural exchange, MKJC and RIMS hereby agree to establish this Memorandum of Understanding.



1. Purpose

The purpose of this MoU is to develop a cooperative relationship between MKJC and RIMS. The collaboration aims to enhance academic and educational exchange and to promote mutual understanding and goodwill.

2. Scope of the MoU

The scope of this MoU includes, but is not limited to, the following areas of collaboration:

- Exchange of students and faculty members for academic, research, and training purposes.
- Joint seminars, workshops, and conferences.
- Collaborative research projects and publications.
- Sharing of all academic resources
- Internship and industry linkage opportunities for students.
- Curriculum development and skill enhancement initiatives.
- IQAC will collaborate on activities such as Academic and Administrative Audits and other NAAC-related assessments

3. Duration and Termination

This MoU shall be effective from the date of signing and shall remain in force for a period of **three (3) years**, unless terminated earlier by either party by giving a written notice of 30 days.

4. Funding and Resources

This MoU does not create any financial obligations on either party. All costs and expenses incurred will be the responsibility of the respective party unless otherwise agreed upon in writing.

5. Confidentiality

Both parties agree to maintain confidentiality of information shared and shall not disclose any proprietary information to third parties without prior written consent.



6. Amendment

Any changes or amendments to this MoU shall be made in writing and signed by authorized representatives of both parties.

7. Dispute Resolution

In case of any dispute arising out of or in connection with this MoU, the parties shall attempt to resolve the dispute amicably through mutual discussion.

8. Legal Status

This MoU is not intended to create any legal binding obligations between the parties. It is a statement of intent to foster genuine collaboration.
