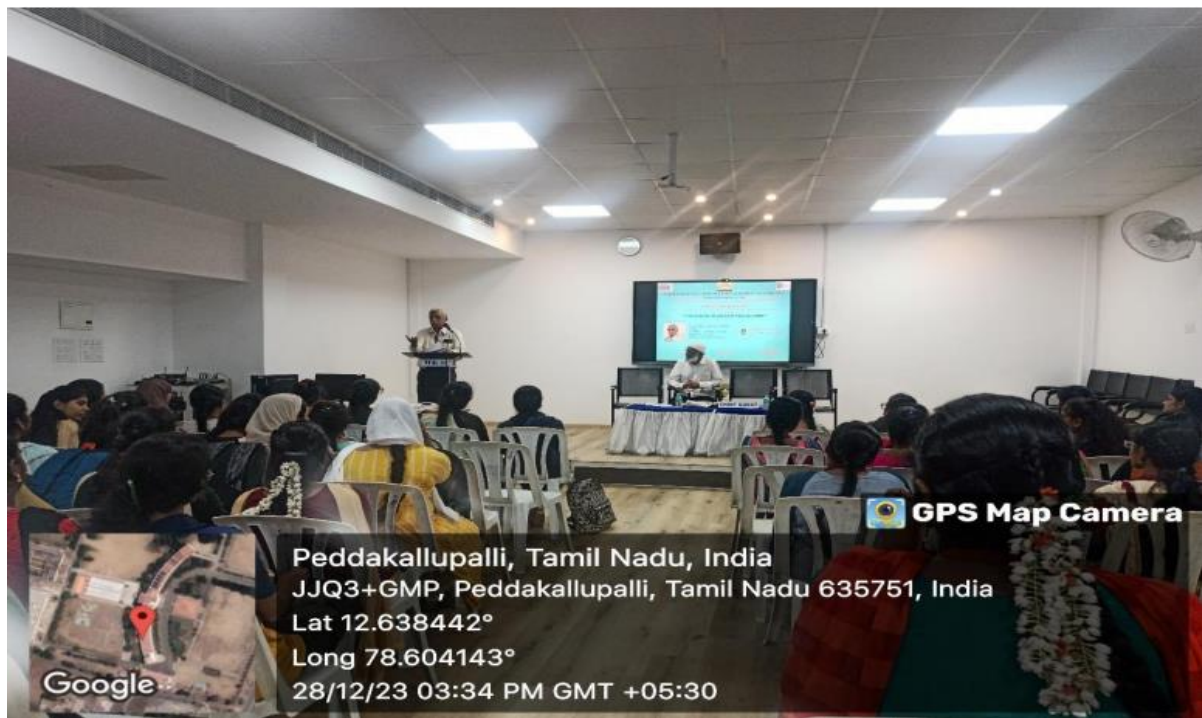
The participants got lot of knowledge on the topic consumer protection laws and totally 105 students are benefited out of this seminar.
