The memorandum of Understanding (MOU) is effective as of establish an affiliation by and between

Department of Business Administration, Marudhar Kesari Jain College, Vaniyambadi of the first part

And

Department of Business Administration, Saradha Gangadharan College, Pondicherry of the second part for the purpose of exchange of faculty and students.

The aforesaid departments are hereinafter referred to individually as department and collectively as departments.

Preamble

Whereas, Department of Business Administration, Marudhar Kesari Jain College, Vaniyambadi, and Saradha Gangadharan College have many areas of common interest in Business Administration may be gained from their pursuit on a collaborative basis in the field of education.

Now therefore Department of Business Administration, Marudhar Kesari Jain College, Vaniyambadi, and Saradha Gangadharan College have decided to enter into this MoU), which defines the framework for the co-operation of the two departments set out in the following sections.

Article1: Object

Both departments agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.

The two departments shall seek to promote:

a. Faculty Exchange

- a) The exchange of faculty to the mutual benefits of both departments,
- b) Collaboration in teaching, research and development in the field of mutual interest,
- c) The exchange of academic materials and publication,
- d) Conducting Lectures,
- e) Understanding join research,
- f) Attachment of staff for purpose of curriculum development and upgrading of teaching and research skills,
- g) Participating in seminars, Symposium and other types of academic discussion,

A specific plan will be worked out for each activity, setting forth detailed arrangement for collaboration will be agreed terms and condition for each visit or an arrangement or such exchange, including those concerning funding and housing will be worked out between the departments.

b. Student Exchange

Department of Business Administration, Marudhar Kesari Jain College, Vaniyambadi, and Saradha Gangadharan College agree that student exchange will be guided by heads of departments listed below. A home institution refers to the institution that receives a student for a period of time to undertake a predetermined program of study

- a) Exchange students will be selected by mutual agreements between the departments,
- b) Participating in seminars, symposiums and other types of academics discussion,
- c) Participating in lectures organized by the departments,
- d) The host institution will evaluate an exchange student's performance in each course or module, award a letter grade or marks, and issue a letter or certificate to that effect,
- e) Expenses for the students are discuss between the departments time to time,
- f) Permit the students, staff and faculty members of both the departments to use library facility in the respective colleges.

Department of Business Administration, Marudhar Kesari Jain College, Vaniyambadi, and Saradha Gangadharan College agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two departments. These terms shall include a technique description of proposed activity, financial arrangement and person(s) responsible for its implementation

Article 2: Coordination

Each department shall appoint one member of its teaching faculty to coordinate the programme on its behalf. Further, a coordination committee consisting a programme coordinator from the side of Department of Business Administration, Marudhar Kesari College, Vaniyambadi and a programme coordinator from the side of Saradha Gangadharan College will periodically review and identify ways to strengthen cooperation between the two departments.

Article 3: Validity

The MoU shall remain in force for a period of THREE years with effective from the date of signing. Departments may extend the terms by written agreement signed by both after review.


Article 4: Termination

Either department may terminate the MoU by giving written notice of three months in advance to other department.
